Key Findings

Drug Deaths
40%▲

from 7.2 to 10.1 deaths per 100,000 adults age 65 and older between 2019-2021 and 2022-2024.

Geriatric Clinicians

36%▲

from 32.0 to 43.5 per 100,000 adults age 65 and older between Sept. 2021 and Sept. 2025.

Suicide

16%▲

from 15.7 to 18.2 deaths per 100,000 adults age 65 and older between 2018-2020 and 2022-2024.

Strengths

- Low prevalence of frequent mental distress
- Low prevalence of food insecurity

Challenges

- High early death rate
- Low level of community support expenditures
