Motor Vehicle Deaths

179%▲

from 3.9 to 10.9 deaths per 100,000 adults age 65 and older between 2022 and 2023.

Geriatric Clinicians

30%▲

from 57.0 to 74.1 per 100,000 adults age 65 and older between Sept. 2018 and Sept. 2025.

Nursing Home Quality

25%▲

from 28.1% to 35.0% of certified nursing home beds between Sept. 2023-Nov. 2023 and Sept. 2025-Nov. 2025.

Strengths

- Low prevalence of full-mouth teeth extractions
- Low prevalence of food insecurity

Challenges

- Low level of community support expenditures
- Low number of home health care workers per 1,000 older adults
