Summary

Strengths:

- Low coverage of smokefree laws
- Low flu vaccination coverage

▼15% in the past five years from 64.0% to 54.2% of certified nursing home beds rated 4- or 5-stars

EARLY DEATH

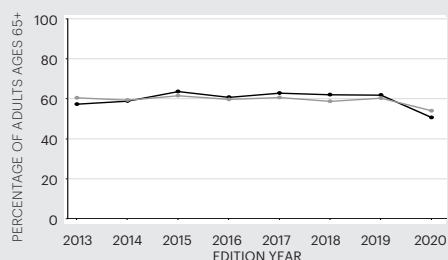
▼11% since 2013 from 1,729 to 1,533 deaths per 100,000 adults ages 65-74

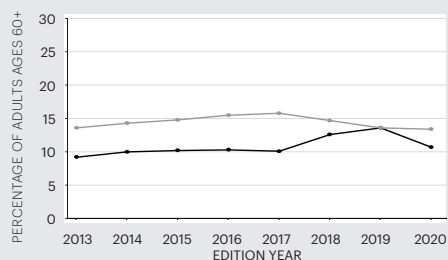
▼23% since 2013 from 8.1% to 6.2% of adults ages 65+

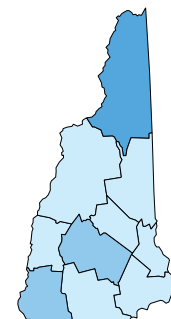
Risk of Social Isolation

Social isolation, defined as an absence of meaningful social relationships, can negatively impact physical health and mental well-being of seniors. The risk of social isolation measure can be used by states to identify counties in greater need of interventions that alleviate isolation and loneliness in older adults.
